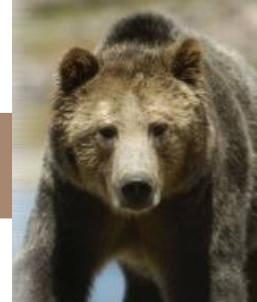


# Premiere Truck Wash and Guard
